Position of the course

This traineeship has as purpose to allow the student to take part in an active and participating manner in the clinical practice of the family doctor. The purpose is that the student sees a number of frequently occurring or important diseases with the presenting complaints, technical investigations and that he can manage these indepently (under supervision). This traineeship follows other traineeship in family practice and theoretical lessons. Specific aims are: the applications of adequate diagnostic strategies, starting from concret patient cases; gaining insight in the epidemiology of important clinical entities; constructig "diagnostic landscape" and developing adequate medical decision techniques. Giving attention for the psychosocial context of the patient: gaining insight in the importance of the history, physical examination, additional technical investigation, therapy, support and advice. Gaining insight in referral processes between primary and secondary care, in the importance of multidisciplinary collaboration, regularly contact with important disease (repetition effect)
