Position of the course

In the interdisciplinary collaboration in mental healthcare, the nurse is an essential and professional partner. The mental health nurse offers a complementary contribution to the care, treatment and recovery of patients with a psychological and/or mental problem or vulnerability. Internationally, there is an increase in professionalization and scientification of mental health nursing. In this course, the foundation of the psychiatry and mental health nursing are provided. The basic assumption is relation-based mental health nursing. The focus is on the individual care context, care setting and society. In this course internationalization is formalized through the frequent use and integration of international scientific publications.

Contents

- Psychological suffering and psychiatric problems in the course of life from a biomedical psychological/psychotherapeutical, cultural-societal, ethical and emotion-oriented nursing perspective.
- History of psychiatry and mental health nursing
- Psychiatric and mental health nursing: a mental health profession with an own identity and societal value.
 - *Function, role and nursing outcomes
 - *Traditional clinical nurse specialist with a (psycho)therapeutical role
 - *Mental health organisation and setting: opportunities/treats for mental health nursing and a reflection on the future
- Debates within psychiatry and mental health nursing
- Emotion-oriented care interpersonal, recovery-oriented bases of the current mental health nurses, strength-bases approach
- Clinical reasoning within mental health nursing
- Situating clinical interventions within a coherent model: individual - group - environment - family and context.

 - *"Psychotherapy for the advanced practice psychiatric nurse" (Wheeler)
 - *Rehabilitation and recovery-oriented working

The student reflects critically on the recovery-oriented and therapeutical interaction and communication and on relevant topics: psychotherapy, Symptom- and illness management, medication management, clinical safety management in care of risks, crisis intervention, care for physical health and healthy lifestyle, mental health prevention, early detection- and intervention, care coordination/case management and collaborative care, ad coaching of the personal recovery(plan) with self-management
