Position of the course

The objective of the professional training is to offer students an organized and guided view behind the screens of the daily functioning of federal, regional and local politics. Through the training students are acquainted with the social reality to which the theories, models and studies they get to know in other educational components refer to. In other words, what is at issue here is getting experience in the empirical situation of daily politics and discovering the relevance and use value of politicological insights. Students have to confront empirical reality and theoretical views with each other and find out to which extent the empirically discovered processes may be approached or explained with the appropriate theories from political sciences. This happens by way of solving a specific research problem fitted to the training. Contents

By way of a temporary, active and goal-oriented participation students are able to get relevant knowledge and experience in the practical functioning of the political occupation. Students personally draw up a political sciences research question, which they will answer on the basis of their training in a research paper. In this BA paper students need to critically demonstrate in which way this experience contributed to their education as Bachelor of Arts in the Political Sciences. For the practical implementation of the internship, we refer to the internship brochure that is made available to the students every academic year. It contains all the guidelines and agreements that exist with regard to the the internship.

Course content-related study coaching

During the professional training, students will be intensively monitored by a person in charge of the training at the Department of Political Sciences (academic staff members, academic assisting personnel, scientific staff members in the fields of study of Belgian and local politics) and by a training mentor at the location of the training. The rights and duties of all parties involved will be drawn up in a training contract, distributed to and signed by all those involved. All parties wil have an extensive training brochure at their disposal.

Extra information on the examination methods

The final evaluation is done on the basis of a combination of the BA paper, linked to the training, the oral defence of this paper, the log book students are required to keep, the different evaluation forms that are kept both by the student and by the training mentor, the evaluation by the person in charge of the training and the submitted project proposal in which students are required to clearly describe the objective of the training and the research questions that need to be answered. Combination of non-periodic and periodic assessment. In keeping with article 72 of the exam regulations, and due to the specific nature of this educational component, there is no opportunity for a second exam for the component consisting in the training. The training is organized within the limits of the year system. The training will take place in the first semester, from Monday to Thursday.

Evaluation: written (paper) and oral (defence).

The training is followed by an oral defence of the BA paper before an examination jury. This jury will be composed of the course titulars, the promotor (in so far this is a different person from the lecturers), the person in charge of the training, and if necessary also the training mentor.

For the written paper and oral defence, criteria obtain concerning the way in which students have involved the training in their answering of the scientific research question.

Central to this evaluation is, in other words, the way in which students are able to build in an exchange between theoretical knowledge and practical experiences and how they are able to operationalize a scientific research question.

There is no second opportunity at examination for the training. There is, however, one for the BA paper.

Calculation of the examination mark
